16 17	1. I am the Managing Director and Head of Kroll Notice Media Solutions							
18	("Kroll Media"), a business unit of Kroll Settlement Administration LLC ("Kroll"),							
19	the Settlement Notice Administrator appointed for this Settlement. ¹ This declaration							
20	is based upon my personal knowledge as well as information provided to me by my							
21	associates and staff, including information reasonably relied upon in the fields of							
22	advertising media and communications.							
23	2. This declaration supplements the <i>Supplemental Declaration of Jeanne</i>

CLAIMS RECEIVED

3. As of October 30, 2023, and with the claims period still ongoing, Kroll has received 272,716 Registration/Claim Forms, of which 272,175 were submitted electronically online and 541 were submitted via mail. In my opinion, the level of Class Member engagement with the (ongoing) notice program has been encouraging and is consistent with other successful court-approved notice programs.

4. Kroll continues to receive and process Registration/Claim Form submissions and will continue to report to Counsel on the status of the claim intake and review. The deadline for Class Members to submit a claim is no earlier than December 16, 2026.

NOTICE PROGRAM REACH

I. <u>Direct Email Notice</u>

As stated in the Supplemental Declaration, among other things, 5. 14 3,756,293 "Initial Email Notices" were sent through this campaign. A total of 15 467,789 emails bounced back and were not deliverable. Of the 467,789 bounced 16 back emails, Kroll had a valid secondary email for 387,333 Class Members and 17 made a second email attempt. Of those secondary emails, 40,552 emails bounced 18 back from this attempt. For the 80,456 who did not have a valid secondary email 19 address and the 40,552 whose secondary emails were bounced back, Kroll mailed a 20 postcard to those with a valid mailing address. 21

6. As stated in the Supplemental Declaration, pursuant to the Preliminary Approval Order, Kroll substantially completed the Direct Mailed Notice by September 11, 2023, having sent postcard notices to 4,572,584 potential Class Members. Kroll continues to process, trace and remail notices as necessary.

7. As of October 30, 2023, 2,775 postcard notices were automatically remailed by the United States Postal Service ("USPS") using the current forwarding address on file with the USPS. There were an additional 770 postcard notices the USPS returned to Kroll with a forwarding address, and Kroll then remailed to these Class Members.

8. As of October 30, 2023, 214,050 postcard notices were returned by the
USPS as undeliverable as addressed, without a forwarding address. Kroll ran
152,902 undeliverable records through an advanced address search. The advanced
address search produced 96,255 updated addresses. Kroll has re-mailed postcard
notices to the 96,255 updated addresses obtained from the advanced address search.
Kroll will continue to run traces on the remaining 61,148 undeliverable postcard
notices and any further undeliverable postcard notices received.

III. <u>Reminder Email Notice</u>

14 9. Following conferral with Co-Lead Class Counsel and Toyota's Counsel 15 (collectively, "Counsel"), Kroll caused a "Reminder Email Notice" to be sent to the 16 3,552,276 email addresses on file for Class Members who received the Initial Email 17 Notice and had not yet filed a Registration/Claim Form or who did not unsubscribe 18 to future Settlement related emails. A true and correct copy of a complete exemplar 19 Reminder Email Notice (including the subject line) is attached hereto as Exhibit A. 20 On October 29, 2023, the sending of the Reminder Email Notice was completed. As 21 of October 30, 2023, of the 3,552,276 emails attempted for delivery, currently 22 97,237 emails were rejected/bounced back as undeliverable.

IV. <u>Supplemental Digital Media Notice</u>

10. To capitalize on the Class Notice Program's visibility and robust
claim rate, the parties have agreed to provide additional supplemental online notice
in both English and Spanish, in addition to the publication and media notice
previously described in the Supplemental Declaration. Over 2,000,000 impressions

1 will be served across contextually relevant web properties where Class Members 2 are likely to visit, according to comscore data. These websites feature English and 3 Spanish news, sports, weather and/or entertainment content. Additionally, ads will 4 be targeted to a custom allow list of premium web sites including cnn.com, 5 cbssports.com, accuweather.com, nbc.com, people.com, and Univision.com, among others. This supplemental digital media notice campaign commenced on 6 7 October 25, 2023, and will be completed within 30 days. Given the extended 8 period over which claims can be filed, the parties will continue to monitor filing 9 rates and evaluate the utility of further supplemental notice. **Settlement Website** 10 V. The interactive, case-specific website, 11 11. 12 https://www.airbagcontrolunitsettlement.com, which was launched on August 11, 2023, has seen continued traffic to it. As of October 30, 2023, the Settlement 13 website has tracked a total of 975,820 unique users who registered 2,585,916 page 14 15 views. Kroll will continue to update and maintain the Settlement website throughout the settlement administration process. 16 17 VI. Toll-Free Telephone Number 18 12. Kroll maintains a 24-hour, toll-free telephone line that Class Members 19 can call to obtain information about the Settlement. During business hours, Kroll's 20 call center is staffed with operators who are trained to answer questions about the 21 Settlement. As of October 30, 2023, Kroll has received 19,377 calls to the case 22 telephone number. 23 **REQUESTS FOR EXCLUSION/OBJECTIONS RECEIVED** As set forth in the Preliminary Approval Order, timely requests for 24 13. 25 exclusion were to be mailed to the Settlement Notice Administrator and postmarked 26 on or before October 20, 2023. As of October 30, 2023, Kroll's records indicate that 27 28

it has received sixty-seven (67) timely requests for exclusion. A list of the valid requests for exclusion is attached hereto as **Exhibit B**.

14. The deadline for submitting an objection to the Settlement was also October 20, 2023. Although Class Members were not instructed to submit their objections to the Settlement Notice Administrator, Kroll's records reflect that as of October 30, 2023, it has received zero written objections directly from Class Members who sought to object.

CONCLUSION

In my opinion, the Class Notice Program, including the Direct Mailed 9 15. 10 Notice and the supplemental publication and media notice program, reflects a highly 11 targeted, well-tailored and contemporary way to provide notice to Class Members. 12 Indeed, the Class Notice Program reached over an estimated 95% of potential Class 13 Members, on average, an estimated three times, in both English and Spanish, through both Direct Mailed Notice (including email notice) and additional 14 15 supplemental notice in print and online. In my opinion, the efforts undertaken in this Class Notice Program are of the highest modern communication standards, are 16 17 reasonably calculated to provide notice, and are consistent with—if not more than-18 best-practicable, court-approved notice programs in similar matters and the Federal 19 Judicial Center's guidelines concerning appropriate reach.²

16. If warranted and/or requested, I can provide a supplemental declaration
to the Court prior to the final approval hearing to provide updated information
regarding the implementation of the Notice Plan and the claims administration
process.
